### **Locations:**

**Laguna Beach, CA (August 23-28, 2008):** The Laguna Adventure is open to ages 13 to 18. This Adventure trip is a great way to skim where it all started. Laguna Beach, the birthplace and heart of skimboarding, is located in Southern California and is home to a number of world-class skim breaks. The Adventure's main focus is to skim with a group of friends during Laguna's south-swell summer season and get pointers from Paulo and Jason while doing so. Other possible activities include surfing, skateboarding, and flowriding. Whether or not it's your first time to Laguna, let Alley-Oop Adventures show you Laguna's unique coastline and variety of skimable breaks.

**Cabo San Lucas, Mexico (January 8-13, 2009) and (April 2-7, 2009) :** Cabo is an obvious location for an Alley-Oop Adventure trip for one reason; it is one of the best places, if not the best place, to skim in the world. ## **Important Travel Info**

### **Where/When to purchase airfare**

AO Adventures recommends purchasing your airfare sooner than later, in fact we recommend purchasing your airfare as soon as you've received confirmation of your sign-up. To alleviate multiple trips to and from the airport, we have set up recommended arrival and departure times. Please schedule your flights to arrive on the first date of the Adventure between 11-2pm and depart the morning of the last day no later than 1pm. For example, the Cabo Adventure is from January 8-13. Schedule your arrival on January 8th around 1pm and departure the morning of January 13th around 12pm. We may be able to offer some good tips for finding the right flight for you.

**Cabo San Lucas:** The main airport in the Los Cabos region is in San Jose del Cabo (SJD). It is about 45 minutes from downtown Cabo San Lucas. Please fly into SJD between 11pm-2pm where we will arrange airport pick-ups accordingly. Many U.S. airlines fly to and from the Los Cabos airport such as Delta, American, and Continental.

**Laguna Beach:** The closest airport to Laguna Beach is John Wayne Airport in Santa Ana (SNA). It is only about 20 minutes from downtown Laguna. Schedule your arrival between 11am-3pm to ensure pick-up. There are several surrounding airports such as Long Beach (LGB), Ontario (ONT), and Los Angeles (LAX). You may find cheaper airfares into these airports, however be sure to schedule a shuttle to John Wayne Airport during the pick-up time. If you prefer a quicker, direct pick-up by AOA, you will be charged \$30, however be sure to notify AOA before scheduling your flight.

**Travel Insurance:** Alley-Oop Adventures recommends comprehensive travel insurance which includes coverage for the following: trip cancellation & interruption, baggage delay, baggage coverage, travel delay, emergency medical and dental, emergency medical transport & evacuation, and travel accident insurance. **ALLEY-OOP ADVENTURE PARTICIPANT EXPRESS ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND INDEMNITY AGREEMENT.**

**Please read and be certain you understand the implications of signing.**

A. Express Assumption of Risk Associated with Sport, Venue Use, and Related Activities.

do hereby affirm and acknowledge that I am aware of and/or have been fully informed of the inherent hazards and risks associated with the **Alley-Oop Adventure**, skimboarding, transportation of equipment related to the activities, and traveling to and from activity sites and participating in those activities of the **Alley-Oop Adventure** in which Participant is about to engage and I hereby expressly assume the hazards and risks associated with these activities..

**Inherent hazards and risks of the Alley-Oop Adventure and related activities include but are not limited to:**

1. Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and back or other bodily injuries that may result in permanent disability and death.
2. Possible equipment failure and/or malfunction or misuse of my own or others' equipment.
3. I AGREE THAT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, neck or spinal cord.
4. Variation and/or steepness of terrain, variation or changes in surfaces including but not limited to sand, shore, skimboarding surfaces, submerged hazards, rocks, stumps, debris, cliffs, trees, fences, posts, signs, buildings, roads, walkways, ramps, rails, man-made riding features, jumps, other persons, and other natural and man-made hazards.
5. My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, weather, riding surfaces or other obstacles.
6. Exposure to the elements and temperature extremes may result in heat exhaustion, heat stroke, sunburn, and dehydration.
7. Dangers associated with exposure to natural elements include but are not limited to high surf, severe surf conditions, undertow, ocean current, rip tide, shore break, marine flora and fauna, rocks, gravel, coral, rock fall, inclement weather, thunder and lightning, severe and or varied wind, extreme.
8. Accidents or illness occurring in remote places where there are no available medical facilities.
9. Fatigue, exhaustion, dehydration, and/or dizziness, which may diminish Participant's reaction time and increase the risk of accident.

10. Impact or collision with other athletes, spectators, Alley-Oop Adventure participants, Alley-Oop Skim Adventure staff, guides and affiliates, waders, swimmers, persons in the water or on the shore, pedestrians, motor vehicles, watercraft rocks, water, cliffs and other natural and man-made hazards.

**\*I understand the description of these risks is not complete and unknown and I understand that unanticipated risks may result in injury, illness, or death.**

**B. Release of Liability, Waiver of Claims and Indemnity Agreement**

In consideration for being permitted to participate in the Alley-Oop Adventure described and related activities, I hereby agree, acknowledge, and appreciate that:

- 1. **I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURIES, DISABILITIES, DEATH,** or losses or damagee to person or property, **WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE** Alley-Oop Skim Adventures, Alley-Oop Skim, Inc. and their owners, officers, directors, employees, representatives, agents, staff, affiliates, guides and volunteers, Jason Wilson, Corey Mahoney, and Paulo Prietto (hereinafter collectively referred to as "Releasees").

I HEREBY RELEASE THE RELEASEES from any and all liability and responsibility whatsoever and from any claims or causes of action that Participant, Participant's estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the participation in the Alley-Oop Skim Adventure and related activities, whether caused by active or passive negligence of the Releasees or otherwise. - 3. By entering into this Agreement, I am not relying on any oral or written representation or statements made by the Releasees, other than what is set forth in this Agreement.
- 4. This Agreement shall apply to any and all injuries, disabilities, death, or losses or damage to person or property occurring at any time after the execution of this Agreement.

This release shall be binding as fully permitted by law. If any provision of this release is found to be unenforceable, the remaining terms shall be enforceable.
